<p>10:00 AM</p>	<p>The Legislative Process- Zenobia Haynes Paramount Consulting</p> <ul style="list-style-type: none"> ● Legislative session runs for 40 days ● Step 1: Introducing an idea <ul style="list-style-type: none"> ○ Contact your state legislator to present the idea ○ Scott Hilton is the state representative for KIPP Atlanta Schools ● Step 2: Georgia General Assembly <ul style="list-style-type: none"> ○ Visit Office of Legislative Council where an attorney can help the state representative to draft the bill ● Step 3: Georgia Legislative Session <ul style="list-style-type: none"> ○ First reading: The legislation is introduced the body ○ Second reading: The bill is assigned to a committee ○ The committees is where the work begins to happen ● Step 4: Third Reading <ul style="list-style-type: none"> ○ After bill has passed through the committee is ready or third reading and placed on the general calendar ● Step 5: The Vote <ul style="list-style-type: none"> ○ The bill is presented to the floor of the house where it originated. All state senators and representatives vote to pass the bill. This is reviewed in real time via electronic screens in front of the House and Senate ● Step 6: The Governor's Role <ul style="list-style-type: none"> ○ The governor can ask to sign or veto bill once it has passed both chambers ○ The governor has six consecutive days after a bill passes to sign or veto if the legislature is still in session. ● Step 7: The Bill Becomes Law <ul style="list-style-type: none"> ○ Once a bill is signed (or not signed) by the governor, all the news acts and laws are printed in the Georgia Law series and added to the Official Code of Georgia Annotated.
