March 26, 2025 - The meeting was called to order at 9:04am by Frank and Deb.

I. Development Highlights & Updates

- A. Development team showed a series of videos and photos highlighting the recent events: Career Day at Delta Air Lines, Night of Impact, Best of KIPP: Umoja, KIPP Families "Literacy on the Go"
 - The committee provided feedback of the success being witnessed and seen in these events, impacting donors, scholars and our community

- B. KIPP ATL Experience School Tours
 - 1. Tours aim to be more impactful and story-centered, focusing on specific school needs (ex., video of Principal Jones, principal of KSFA, highlighting technological needs)
 - The Development department encourages the board & committee
 to invite partners and associates to join us for a scheduled or
 personalized tour to see our schools in person (ex. Mrs. Kathe
 Brown coordinating a personalized tour for a donor associate to
 visit KAC)
- C. AYSTAK (April 24): The development department suggested turning this into a gratitude event to honor KIPP's emeritus board members.
 - The committee recommended reconsidering alternative options to honor these board members and maybe plan to sunset AYSTAK and reallocate resources to other funds.
 - 2. Joe Arnold suggested dinner for honorary board members (ex., the night before a strategic board meeting)
 - 3. A suggestion was made to hold private showings and comp tickets for future scholarly plays (e.g., The Lion King, Aladdin, etc.).
 - 4. Dr. Harris will provide insight into this decision by Friday, March 28.
- D. Reveal the Shield (May 15)
