At KIPP Atlanta Schools, we believe that **nourished scholars are better learners**. That's why we provide **free breakfast, lunch, and after-school snacks** to all scholars, every school day.

Our meal programs are made possible through support from the **U.S. Department of Agriculture (USDA)** via the:

- National School Lunch Program (NSLP)
- School Breakfast Program (SBP)
- After School Snack Program

Thanks to our participation in the **Community Eligibility Provision (CEP)**, we are proud to offer these meals **at no cost to families**—with **no application required**.

What is the Community Eligibility Provision (CEP)?

The **Community Eligibility Provision (CEP)** is a federal option available through the USDA that allows eligible schools to serve **free meals to all scholars**, regardless of family income.

By adopting CEP, KIPP Atlanta Schools:

- Eliminates the need for meal applications, reducing paperwork for families and school staff
- Provides equitable access to meals, ensuring that no child goes hungry due to financial circumstances
- Supports dignity and inclusiveness, removing the stigma sometimes associated with free or reduced-price lunch
- Improves academic focus and attendance, as scholars are more likely to start the day nourished and ready to learn
- Maximizes participation in school meal programs, contributing to healthier eating habits for all scholars

This supports scholars during our extended school day, many of whom also stay late for tutoring, clubs, athletics, or other enrichment activities—ensuring they remain energized and focused throughout the extended day.

School Nutrition Nondiscrimination Statement
