- B. A discussion was had regarding progress against the 2023 baseline year for CSI/TSI exit and implications for each school's projected ability to meet cut scores and outperform prior-year content mastery.

- A. A discussion was had regarding projected CSI, TSI, and ATSI identification and exit conditions. Committee members discussed school-level strengths, areas of risk, and mid-year trends, with a focus on students with disabilities as a key subgroup influencing TSI/ATSI status.

### III. Semester 2 Priorities & Academic Acceleration

- A. A discussion was had regarding the region's plan to prioritize Semester 2 instructional execution, targeted intervention, and data monitoring to support academic acceleration and mitigate risks to exiting CSI/TSI/ATSI designations.
